



This Memorandum of Understanding (MoU) sets for the terms and understanding between HackersEra Cyber Security Consultancy & Training Firm and Department of Computer Engineering, Vidyavardhini's College of Engineering and Technology (VCET), Vasai for Industry institute collaboration. AND

Department of Computer Engineering, Vidyavardhini's College of Engineering and Technology (VCET), Vasai (hereinafter referred to as "VCET Vasai" which expression shall unless repugnant to the meaning thereof, mean and include its successors and permitted assigns) of the SECOND PARTY.

(HackersEra and VCET VASAI are individually referred to as "Party" and collectively as the "Parties").



Hackers Era Background

HackersEra is a Global Enterprise for IT Security Training & Security Consultancy that focus on solving IT security Issues. It is Trusted Standard for companies to Protect their Products, Brands & Confidential Reports from Various Types of Cyber Attacks The Company Serves IT Security Training & consultancy Services to Business, Governments and institutions over globe.

1. Scope of the MoU

The purpose of this MoU is to reach an understanding between the Parties in relation to conduction of workshop & training in the area of Information Security & Advance Ethical Hacking, Cyber Security, FDP (Advance Ethical Hacking) as well as Cyber Security Awareness Program, organized by "VCET VASAI" and delivered by HackersEra.

- HackersEra will successfully deliver all the workshop(s), training(s) and awareness program
 as mentioned in this MoU.
- HackersEra will provide internship offers to students participating in Advance Ethical Hacking training program subject to technical review.
- HackersEra will extend consultancy in evaluating research outcomes of students and provide research directions.
- HackersEra will provide training, Digital Kit (Study Material, Software, Tools), and all necessary post workshop documentation to each and every student.
- HackersEra will ensure adequate training team comprising of experts and assistants and will also ensure the completion of the course.
- HackersEra will represent "VCET VAS TENDS vorkshop partner in various available publicity and available stationary formats publicity posters, proposal, certificates, website, forums, press releases, media corcia e etc. where er HackersEra conducts workshop.

- HackersEra will get all the promotional material verified by "VCET VASAI" team before using it
- HackersEra will provide the free certification and appreciation letters and certificates to the college coordinators and ambassadors.
- HackersEra will mention "VCET VASAI" on the global site, study material and everywhere in/on the marketing material.

4. DELIVARABLES OF "VCET VASAI"

- "VCET VASAI" will provide hospitality (lodging, boarding and pick & drop from airport/railway station) to HackersEra team for workshops during the fest itself without any charge.

- "VCET VASAI" will be providing a hall/room with a seating capacity (maximum 150/350) during the fest at "VCET VASAI".
- "VCET VASAI" will allow HackersEra to put the logo and name of "VCET VASAI" on its corporate merchandise and stationary which includes posters, proposal, certificates, website, forums, press releases, media conclave etc.
- "VCET VASA!" will designate HackersEra as an official sponsor (workshop partner) on fest and its website and to include the name and logo of HackersEra in every type of poster, flex, android app (sponsors tab), newsletter etc. till the validity of MoU.
