Your sealed envelope should contain DD towards EMD (Earnest Money Deposit) the detailed product specifications, literature, all the documents needed to fulfill the terms and conditions mentioned in later part of this tender document and **document properly filled with the competitive price offered, duly signed and stamp sealed otherwise it is liable for rejection.**

The place of delivery should be at College site and delivery period should not exceed more than Six Week or otherwise decided mutually from the date of Purchase Order.

Please note that the last date for submission of quotation is on or before 3 p.m. 2nd May 2022 and will be opened at 4 p.m. on this day at Principal office Vidyavardhini’s college of Engg & Tech Vasai Road (W)

You are requested to pay Rs. 1000/- (One thousand only) by cash or by a separate demand draft towards tender cost in favour of ‘Vidyavardhini College of Engineering and Technology’ along with each quotation, in addition to DD for EMD, copy of the cash receipt for the cost of tender form or the separate D.D. in original must accompany the tender document for its submission

Terms and Conditions:

1. Earnest Money Deposit (EMD) amount is to be paid by D.D. of nationalized bank, payable Mumbai in Name of "Vidyavardhini's college of Engg and Tech". The EMD is refundable.
2. The EMD amount value is to be "calculated" on the basis of 3 % of the "total cost" for all the items quoted by the tenderer for the respective item.
3. The Bidder should submit the documentary proof for the execution of the at least three orders for the supply of the similar items approximately of the same amount as quoted in his offer.
4. The Bidder should submit the proof that he is running the business for last 3 years.
5. The bidder should have registration on GM portal. Registration number need to supply in quotation.
6. The Bidder shall assure the support and supply of spares for at least 3 years for the products quoted after the Warranty / Guarantee period. If the Bidder is not manufacturer, then the manufacturer on his letterhead should give above commitment.
7. Bidder should attach the appropriate certification of product as per requirement along with literature document enclosed.
8. Bidder shall not **assign or sublet the contract** to any other sub-vendor.

9. Bid Price

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initializing, dating and re writing in words.
 - b) **All duties, taxes and other levies etc. as applicable are payable by the bidder under the bid and shall be included in the total price.**
 - c) The rates quoted by the Bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
 - d) The prices should be quoted in Indian Rupees only.
10. Each Bidder shall submit only one quotation/ Tender.
11. Supplier should enclose his latest valid Income Tax clearance certificate along with his GST Registration No. and Certificate.

12. Validity of Quotation

Quotation shall remain valid for 30 days after the last date specified for submission.

13. Evaluation of Quotations

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed; and
- (b) Conform to the terms and conditions, and specifications
- (c) Evaluation and Comparison of bids shall be done on basic price with charges like transportation, freight and insurance, training, commissioning, installation etc.excluding all taxes. Thus, rate should be given clearly indicating basic price. and other charges (if any)

14. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive reliable with and quality and service.

15. A) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and/or to cancel the bidding process and/or reject all quotations at any time prior to the award of contract.
- B) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order. The bidder shall submit a “Undertaking” on legal bond document
- The complete delivery of all the items should be within 30 days from the date of Purchase order.**
16. Payment will be made immediately after delivery of the goods in following mode:
100% against delivery at college site after satisfactory Installation and demonstration. Normal commercial warranty/ guarantee shall be applicable to the supplied goods as follows.
- For 18 months from date of satisfactory Installation/acceptance.
 - Maintenance and/or repair of supplied goods for a period of 18 months after the end of warranty period.
17. In case of dispute, persons appointed by Principal, VCE Vasai will act as Conciliator. All legal disputes are subject to the Jurisdiction of Mumbai court only.
18. **Right to change any clause fully or partially in the terms and conditions mentioned above and right to cancel any quotation without giving any reason is reserved with Principal, Vidyavardhini’s College of Engg & Tech Vasai Road (W). No request for change in specification will be entertained.**
