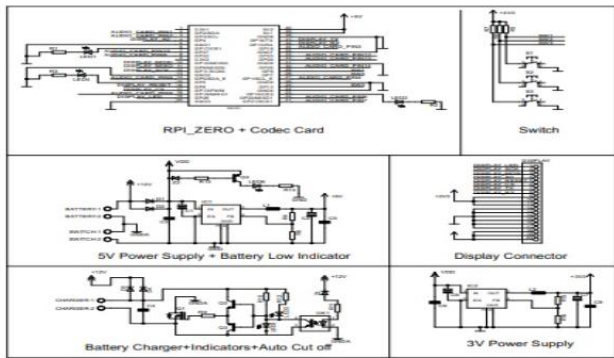

(57) Abstract :
