Institute Research Policy



Revise Institute Research Policy

To encourage and assist the faculty members of the Vidyavardhini's College of Engineering and Technology in indulging in research, the following guidelines are issued

1. STTP/FDP/Training

- A short-term training program organised/approved/in collaboration with AICTE/ QIP by IIT/NIT/NITTR/ATAL/IIIT/IISc/IIM
- Faculty can attend FDP / workshop/ Seminar during semester break. Staff members will be sponsored 50% of expenses, limited to Rs 5000 out of Mumbai Metropolitan region.
- Faculty are encouraged to attend FDP / workshop/ Seminar without disturbing the regular academic schedule.
- The reimbursement application in Annexure A, the certificate of attendance and a copy of the paper must be submitted.

2. MOOC Courses of SWAYAM /NPTEL

- 50% of one course's registration fees per semester for completing the course.
- The reimbursement application is in Annexure B, and the certificate must be submitted.

3. Conference Paper Presentation

- Conference organised by Institute of National Reputation IIT/NIT/GCoE/Autonomous in Collaboration with esteemed professional bodies, indexed in Scopus, Web of Science, etc.
- Staff members will be sponsored for the registration fee, TA/DA, boarding, and lodging as per the rules. The maximum contribution from the Institute will be up to Rs.10000 per annum per staff member.
- Faculty are encouraged to attend the Conference without disturbing their regular academic schedule. However, a maximum of three days' OD can be availed.
- The reimbursement application in Annexure C, the certificate of attendance and a copy of the paper must be submitted.

4. Institute Research Grant

- Faculty members could submit one Minor Research proposal to the Institute for funding each year on or before 31st January.
- Based on the recommendation of the Research Committee, the proposals will be approved.
- The total limit for the institute research proposal will be up to Rs.100000/-
- The proposal will be evaluated at each phase by the research committee.
- Paper publication is mandatory for the research using an institute research grant.

5. Sponsored Grant

| Grant Proposal above rupees 50 lakhs | 100000 |

NOTE

- If all the PI and Co-PI are from VCET itself, then 50% benefit will be given to PI and all other Co-PI's equally share rest 50%
- This also includes grants for conducting seminars, STTP, etc.
- The proposal, purchase, report, and utilisation certification processes should be through the proper channels.

NOTE

- For multiple authors in a book, the benefit will be divided among all internal authors.
- For multiple book chapters, the benefit will be given only once, irrespective of the number of chapters in a book.
- Book chapters published through the conference and local book publications will not be considered for benefit.
- Affiliation of the VCET is mandatory.
- The incentive in Annexure E, the certificate of attendance and a copy of the paper must be submitted.



8. IPR (Patent/ Copyrights)

Patent

- For the Indian Patent, the Institute will be a Co-applicant, and 50% of expenses will be borne by the Institute, a maximum of up to Rs.25000/-
- Submission of a patent application on the MIC-KAPILA Portal is a must.
- In the case of commercialisation, revenue rights will be equally shared.

Copyrights

- The institute should be the Co-applicant for the copy-right application.
- Copy Right should be prior approved by the IPR cell, followed by the principal.
- Copyright reimbursement of 100 % of Registration Fees paid.

NOTE

• An IPR Proposal with a complete draft of innovation should be approved by the IPR Cell before being followed by the principal.

11. Consultancy

The institute's academic staff should be permitted to engage in Consultancy practice to an extent that does not interfere with the discharge of their duties with management's prior permission.

The reasons being:

Various departments offer expertise and a host of specialised facilities that can be used by academia and industry. This is mutually beneficial and recognises the Institute.

Consultancy/Sponsored Research projects enrich experience and knowledge by allowing academics to interact professionally. They also get a chance to experiment under actual service conditions.



Consultancy also allows students to see the sphere of their chosen profession.

Consultancy is carried out (with prior permission) by the staff member or group of staff providing consultancy, who is entitled to retain 30% of the share. The college will retain 70% of the net amount subject to utilisation of the institute infrastructure/OD.

If faculty members do the consultancy without using the infrastructure/OD, they are entitled to 70% reimbursement of the consultancy amount, which will be distributed as mentioned in the table.

After completing the work and obtaining such communication from the client/HOD/Dean R&D, the college will make appropriate payments to concerned staff members.

Remuneration will be paid to consultants and other staff members/students for technical and administrative help in the Consultancy work.
